3.2.1. Survey Results

Purpose and vision statements that had been workshopped at SLT were presented. There was a lot of feedback around 'true potential' and 'lifelong love of learning' – is that realistic, does it speak to everybody. Pathways came through strongly. LH - could we look at joining the second and third options from the Vision statement. $CW - 3^{rd}$ doesn't include 'learning'. We like the notion of every individual, discovering their passion to become a contributing and responsible citizen
