## School overview

Ferny Grove State High School provides an exceptional and distinctive educational experience. Our school is founded on strong values of Respect, Learning, Community and Creativity. Features of our academic excellence programs, exceptional vocational options and our unique Agricultural Studies course together with a wide variety of sporting programs all contribute to the distinctive educational experience at Ferny Grove State High School. Features of Ferny Grove State High include:

- In 2020 over 23% of the students received an ATAR of over 90, and over 98% of our students receiving the Queensland Certificate of Education (QCE)
- In 2020 over 90% of students applying for tertiary placements receive a university offer, with students taking courses such as Bio-Medical Science, Pharmacy, Engineering (Honours), Architecture, Psychology (Honours), Health Sciences, Music, Aviation, Commerce and Laws (Honours), Education, Biotechnology, Nursing
- 72% of graduating students exit with a recognised VET qualification, with over 118 students in 2020 completing a Certificate 3, Certificate 4 or a Diploma level qualification. With 54 students completed/ or completing a School Based Apprenticeship.
- Student leadership culture, pastoral care program and high expectations of student performance
- Enforced uniform, behaviour and mobile phone expectations
- Exceptional student wellbeing support programs
- BYOD laptop program

The school curriculum is broad, enabling students to engage in studies which are of interest to them, preparing them for further study or employment. Students are encouraged to participate in the many extracurricular activities offered to extend their personal development as active and informed young people, contributing to a healthy and harmonious global society.

## Staff profile

### Teacher standards and qualifications

The *Teacher registration eligibility requirements: Policy* (p.1) states:

To be eligible for registration, a person must satisfy the Queensland College of Teachers (QCT) that they meet requirements regarding qualification and experience, or have otherwise met the requirements of the *Australian Professional Standards for Teachers* (APST). A person must also satisfy the QCT that they are suitable to teach and meet English language proficiency requirements. All these requirements are specified in the Act and the *Education (Queensland College of Teachers) Regulation 2005* (the Regulation).

The qualifications required for teacher registration are successful completion of either -

- a four-year initial teacher education program including teacher education studies of at least one year (e.g. a Bachelor of Education, or a double Bachelor degree in Science and Teaching) or
- a one-year graduate initial teacher education program following a degree (e.g. a one-year Graduate Diploma of Education (Secondary) after a three-year Bachelor degree) or
- another course of teacher education that the QCT is reasonably satisfied is the equivalent of (a) or (b). These are considered on a case-by-case basis.

### Notes

1. The 2020 cohort was the first to complete Year 12 under the new senior assessment and tertiary entrance system. The new system has redeveloped senior syllabuses, strengthened school-based assessment, introduced a common external assessment in each senior General subject area and General (extension) and replaced the OP rank with the Australian Tertiary Admission Rank (ATAR). This represents a break in time-series for the Queensland Certificate of Education.
2. ATARs are calculated by Queensland Tertiary Admissions Centre (QTAC). ATAR data is not held by the department.
3. Prior to 2020, visa students (students who are not Australian citizens or permanent residents of Australia) were excluded. From 2020 visa students are included.

## Student destinations

The Queensland Department of Education conducts [annual surveys](#) that capture information about the journey of early school leavers and Year 12 leavers from school to further study and employment.

### Early school leavers

Schools work closely with a range of external agencies to support students who left school early.

Our Principal, Deputy Principal, Regional Transitions Officer or Guidance Officer liaises with early school leavers and their parents, providing a service 'beyond the school gate' to assist early leavers make a successful transition to other educational pursuits or employment.
